Annexure-1

Clause no. 31: The Public Procurement (Preference to Make In India) order 2017- Revision dt. 28-05-2018 will be applicable as given below:

1. In procurement of goods in respect of which the nodal ministry has communicated that there is sufficient local capacity and local competition, and whereas the estimated value of procurement is Rs. 50 Lakhs or less, only local supplier shall be eligible. If the estimated value of procurement of such goods is more than Rs. 50 lakhs, the understated provisions shall apply.
2. In procurement of goods or works which are not covered under clause 1 and which are divisible in nature, the following procedure shall be followed:
 - a. Among all qualified bids, the lowest bid received is from local supplier, than full quantity will be awarded to L-1.
 - b. If the bid is not from local supplier, 50% of the order quantity shall be awarded to L-1. Thereafter, the lowest bidder among the local suppliers, will be invited to match the L1 price for remaining 50% quantity subject to local supplier's price falling in the margin of purchase preference, and contract for that quantity shall be awarded to such lowest local supplier subject to matching the L1 price. In case such lowest eligible local supplier fails to match the L1 price for remaining quantity, the next higher supplier within the margin of purchase preference shall be invited to match L1 price for remaining quantity and so on and the contract shall be awarded accordingly. In case some quantity is still left, uncovered on local supplier, then such balance quantity may be awarded on L1 bidder.
3. In procurement of goods or works which are not covered under clause 1 and which are not divisible in nature, and in procurement of services where the bids is evaluated on price alone:
 - a. Among all qualified bids, the lowest bid received is from local supplier, than full quantity will be awarded to L-1.
 - b. If L1 is not from a local supplier, the lowest bidder among local suppliers will be invited to match the L1 price subject to local supplier's quoted price falling within margin of Purchase preference, and the contract shall be awarded to such local supplier subject to matching L1 price.
 - c. In case such lowest eligible bidder fails to match the L1 price, the local supplier with the next higher bid within the margin of purchase preference shall be invited to match the L1 price and so on.
